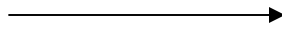

LABOR NOT INCLUDED

TO QUALIFY, APPLICANTS:



- Must circle the size of their family on the chart to the right
- Must be a low or moderate-income family
- Must reside in the house being painted
- Must attend lead safe training & remove all paint chips
- If owner lives at property, he/she must be the applicant

IF YOU QUALIFY, HERE'S WHAT TO DO:

1. COMPLETE THE APPLICATION on the reverse side.
To participate you must apply by **August 28, 2009**. Applications received after 6:00 p.m. August 28, 2009 will **not** be processed.
2. PROVIDE PROOF OF OWNERSHIP (Copy of water bill, deed, W-2)
3. VERIFY **ALL** HOUSEHOLD INCOME (below)
 - This program is funded with HUD funds which target low to moderate income families based on **total household** income. Therefore, participants must verify **ALL** household income.
 - If currently employed, two (2) current paycheck stubs
 - If unemployed, copy of unemployment benefits
 - **OR** social security statements 1-800-772-1213 to request proof

VOUCHER — Available to homeowners and tenants (no money comes out of your pocket)
A list of neighborhood agencies is provided, locate the one closest to your home and call for additional instructions. Mail your application to your local Neighborhood Agency from the attached list: **NOT THE CITY OF CLEVELAND.**

REFUND — Only homeowners can qualify (paint and supplies are purchased, the homeowner will be reimbursed once they submit receipts to the City). You will **NOT** be reimbursed if you paint your home before you are approved for the program.

Paint Program Instructions DEPARTMENT OF COMMUNITY DEVELOPMENT

Two ways to participate: **VOUCHER** or **REFUND**

VOUCHERS: Contact your agency, get paint for free.

1. Find and contact your local Development Agency using the attached list. (Match your Ward or Councilperson with your Agency).
2. Attend a Lead Safety Class & remove paint chips when finished.
3. Your agency will provide you with a voucher(s) if you qualify.
4. Use this voucher to get FREE paint at local paint stores.
5. Paint your house before October 31, 2009.

REFUNDS: Contact the City, buy your own paint and receive a refund if you are accepted.

1. If you are accepted into the program: Attend a Lead Safety Class and purchase paint at your local paint store with your own cash. **SAVE YOUR RECEIPTS!**
2. Paint your house before October 31, 2009 and remove paint chips when finished.
3. When you have finished painting your home mail copies of your receipts and program acceptance letter to the address above.
4. **DO NOT BUY PAINT WITHOUT RECEIVING WRITTEN**
